Heroin seized, 5 arrested in Meghalaya

SHILLONG, AUGUST 1 / - / Five people, including two teenagers and a woman, have been arrested in Meghalaya after heroin worth over Rs 3 crore and Rs 4.5 in cash were seized from their possession, police said on Monday.
Acting on a tip-off, anti-narcotic sleuths of the East Khasi Hills district intercepted one sports utility vehicle at Jingkiengdemthring in Shillong on Sunday.
The police recovered 40 soap cases containing the suspected heroin weighing 559 grams and arrested 19-year-old Shaniakha Khamawphlang.
Upon interrogation, his accomplice 20-year-old Daniel Nongrum of Nongrah Nongpang in Shillong who came to fetch the contraband was also arrested. His bike was also seized, the police said.
The supplier Esther Ramhngai (37) of Manipur's Churachandpur district was arrested from her rented house at Thembasuk Block F of Madanring where police seized Rs 4.42 lakh in cash.
Also present at her house were two couriers - Robinson Hmar (19) of Aizawl's Bawnkawn locality in Mizoram and Letminlen Doungel (30) of Churachandpur's Tuibong locality, the police said.
Both were also arrested and a car, Rs 2.19 lakh in cash, and a scooter were also seized, the police said. The smartphones belonging to the accused were also seized and a case has been registered against them under relevant sections of the Narcotic Drugs and Psychotropic Substances Act, the police said. Prohibitory orders clamped in Charilam area after BJP supporters clash with TSR jawans

AGARTALA, AUGUST 1 / - / Prohibitory order has been clamped in Sepahijala district's Charilam area after a scuffle broke out between BJP supporters and Tripura State Rifles (TSR) jawans on Monday, a police officer said. Two or three BJP supporters were injured in the incident at Charilam, the officer said. Trouble began when Tripura Pradesh Congress Committee president Birajit Sinha was welcoming 603 voters of Charilam Assembly constituency, home seat of Deputy Chief Minister Jishnu Dev Verma to the party fold. A group of BJP leaders and supporters

strongly protested the joining programme of the Congress at Charilam as the police have not given permission for organizing any political programme on the ground of Covid protocol. The ruling party supporters tried to stop the Congress's joining programme but TSR jawans prevented them leading to a scuffle with the security personnel.
Two or three BJP supporters were injured in the scuffle but there was absolutely no clash between Congress and BJP supporters, said a senior police officer. No FIR has been lodged regarding the incident so far, said the

officer. Angry BJP supporters blockaded Agartala-Bishramganj road protesting the police's role as they claimed TSR jawans resorted to lathicharge on the party supporters. However, later, the road was cleared for vehicular movement. Binoy Bhusan Das, the Sub-Divisional Magistrate (SDM), Bishalganj sub-division, said prohibitory order has been imposed at Charilam market and its adjacent areas to maintain peace. Now, the situation is under control and heavy reinforcement have been rushed to the area to thwart any untoward incident, he said. PTI

Meghalaya: SP, DM terrorising workers, BJP seeks their removal

SHILLONG, AUGUST 1 / - / The BJP's Meghalaya unit has alleged that party workers are being terrorised by the superintendent of police and district magistrate of West Garo Hills and sought their removal.
BJP state vice-president Bernard N Marak was arrested last week on the charge of running a sex racket in his farmhouse in the district.
The party, which is part of the ruling coalition, wrote to Governor Satya Pal Malik seeking the removal of the two senior officials of the

request your office to intervene and help restore the sense of safety among our party workers.
Meghalaya is witnessing political vendetta, a first of its kind in the state.
Terrorising opposition and smaller party workers is nothing but suffocating our very own democratic principles.
The BJP with two MLAs is part of the ruling Meghalaya Democratic Alliance government and the party is also backing the National People's Party in the executive committee of the Garo Hills Autonomous District Council (GHADC).
Meanwhile, the saffron party has claimed that Marak's arrest for allegedly running a sex racket in Tura, was a pressure tactic of the NPP as the BJP's state vice-president had charged Chief Minister Conrad K Sangma and his party, the National People's Party, of financial irregularities and corruption in the GHADC.

We are not taking this lightly and our karyakartas are demonstrating against the government's vindictive arrest and harassment against our party workers, he said.
Marak, a former militant leader and an elected member of the GHADC, was arrested from a taxi in Uttar Pradesh's Hapur district last week after the police, raided his farmhouse and rescued six minors and arrested 73 others.
Twenty-seven vehicles, eight two-wheelers, about 400 bottles of liquor, over 500 unused condoms, and crossbows and arrows were seized during the raid in Tura.
While the BJP has accused the chief minister's involvement in the raid at the farmhouse and his subsequent arrest, the latter refuted all allegations.
There is no question of me ever giving any kind of order in that manner, the chief minister had told journalists. (PTI)

Assam records 1.22 pc fall in D-voters since January

GUWAHATI, AUGUST 1 / - / The total number of 'D' (Doubtful) voters in Assam has come down by 1.22 per cent to 1,01,107 in seven months since January this year, Chief Electoral Officer Nitin Khade said on Monday. D-voters are those who could not provide evidence in favour of their Indian nationality.
According to electoral rolls as on January 5, the state had 1,02,360 D-voters - 38,496 men and 63,864

women, Khade said. "This number has come down to 1,01,107 as on July 30 after revision of the electoral rolls.
They comprise 38,001 men and 63,106 women," Khade told PTI here. He, however, said that the Election Commission has no role in deciding whether a D-voter will be able to vote. "Deletion or regularisation of a D-voter is done as per orders of the Foreigners Tribunals and subsequent judgements by higher courts. If the legal system declares one as a foreigner, his or her name is deleted from the electoral rolls."
The concept of D-voters was introduced in Assam in 1997 by the Election Commission. It does not exist anywhere in India.

"If a D-voter is termed an Indian citizen by the judiciary, the prefix 'D' is removed from his or her name. This is how the number of D-voters is decreasing gradually," Khade said.
The issue of D-voters is one of the most contentious topics in Assam's political and social sphere.
Several elections have been fought and won over this single issue of illegal Bangladeshi immigrants, who are initially marked as D-voters if their names are found in the electoral rolls.
The concept of D-voters was introduced in Assam in 1997 by the Election Commission. It does not exist anywhere in India.
During the seven-month period since January, the total number of voters in

2,38,25,522. The state had a total electorate of 2,37,10,834 people in January.
The Chief Electoral Officer said that the number of first-time electors in the age group of 18-19 years also went up to 6,05,422 by the end of July from 4,79,133 seven months ago.
The Election Department on Monday rolled out new user-friendly online voter registration forms for first-timers as part of a nationwide exercise.
Khade said that draft electoral rolls for this year will be published on November 9 and the final list on January 5, 2023.
"We are also carrying out polling station

rationalisation. We have at present 28,205 main polling booths, excluding the auxiliary ones. The upper limit of each booth is 1,500 voters. Considering various parameters, this is being rationalised," he added.
The Election Department also launched voluntary linking of Aadhaar numbers with voter card service from Monday. (PTI)
