



I say, I am familiar and well versed with the concept of electronic voting system as prescribed under the said Rules and the relaxations as provided in the Applicable Circulars.

1) The Management of the Company is responsible to ensure the Compliance with the requirements of the Companies Act, 2013, Rules made there under and SEE! (Listing Obligations and Disclosure Requirements) Regulations, 2015 relating to voting through electronic means on the resolutions contained in the Notice to the 40th Annual General Meeting (AGM) of the members of the Company.
